Their fundraising goal is \$4,000, but will obtain a quote to get a fundraising total. Connie Hoffmann has indicated she would like to help with this. New Business

• Lighthouse Youth Ministry Agreement: David (CTK rep for Lighthouse Executive Board) advised things are going very well with construction of Lighthouse building. The first phase is almost done. First event will be in November will be the Giving Tuesday Fundraising meal, held on the Tuesday after Thanksgiving. Paper information will be sent out. Discussion held regarding Pastor Kelly's function in LYM. Formal understanding is that CTK church is "loaning" Pastor Kelly 5 hrs per week on average to LYM for a 1-year term in exchange of CTK's annual commitment fee to LYM (\$5,000). LYM will forgive CTK the fee for 2019 and will need to send budget request in writing for 2020. Kathy Wiskow made a motion to "loan" Pastor Kelly for 1 year to LYM (5 hrs per week) in lieu of \$5000 payment 2019. Becki Hill seconds the motion. All in favor. None opposed. Motion passes.
